SikaProof<sup>®</sup> ExTape-150 is a cold-applied self-adhesive tape to securely adhere joints, overlaps, connections and details on the membrane side of the SikaProof<sup>®</sup> A system.

SikaProof® ExTape-150 is used together with SikaProof® Tape-150 for easy, fast and secure double bonding of joints and connections. There is only a pressure roller required, to press the tapes firmly into the white fleece layer sides .
