APPLICATION INSTRUCTIONS

APPLICATION METHOD / TOOLS

Tub

Pull off lid and open closure. Find start wipe in centre of roll. Pull out approx 1 foot of wipes and thread through lid. Replace lid immediately and reseal closure.

Flow-pack

Open the plastic lid on top of the flow pack and peel back the inner seal. Pull through the required amount of wipes and then ensure to close the lid to prevent the wipes from drying out. When using on spills, use immediately for the best results.

Spray

Always test a small inconspicuous area prior to full application. Remove the CRC cap and attach the spray head provided. Spray onto the area that requires cleaning and wipe with our Paper Wipe Roll or similar. To extend the life of Sika® Wonder Wipes add some of the spray liquid to the tub, or add directly to a wipe. When using on spills, use immediately for best results.
