SikaBond®-551 is a starch and PVAc based fabric and wallpaper adhesive.

The product meets the criteria for chemical products in BASTA.

USES

The product is used for gluing wallpaper with paper backing, fiberglass fabric, acrylic vinyl structure with paper backing. On substrates of particle board, wood fiber boards, cardboard, plasterboard and commonly used wall materials in dry areas.

CHARACTERISTICS / ADVANTAGES

The adhesive is designed for machine or spray application but is also suitable for application with rollers or brushes. This wallpaper adhesive is approved according to MTB standards.

Consumption	One liter is sufficient for 4m ² (wallpaper set). However, the mesh length must always be adapted to the material and the substrate.

Tools and spots should be washed off with water before the product have dried.
